

The follows is the article of the internet news 'Taekwonline' which is one of the **most famous Taekwon-Do news in South Korea.**>

Mr. Hwang, the president of the KoreaAmerica Taekwon-do Union, told the truth. He was General Secretary of the group led by the illegal president Mr. Chang Ung, but he was expelled from the group on the 21 FEB 2004.

Mr. Hwang called Mr. Chang swindler when he had an interview with the internet broadcasting, Taekwonline.Com. And he told the illegal works of Mr. Chang.

He said "Mr. Chang Ung and Mr. Kim Un Yong(the ex-president of World Taekwondo Federation) had all the scenario which nobody knows except them. Mr. Kim wanted to collapse the ITF and make it be included to WTF. His final object was that he has the powerful authority and private interests in the international sports community with using the title of Taekwondo and Taekwon-Do." He also said "For Mr. Kim the late Gen. Choi was the serious obstacle to progress his own project. So he chose Mr. Chang and gave hundreds of thousand USD for drawing Mr. Chang into his side. At then, the death of Gen. Choi was became a good chance to them."

"As you know, Mr. Chang was just a basketball coach, not a Taekwon-doist. he has done everything illegally with making Taekwon-do his own method for the interests of his country and his private interests. He also was given much money which the government of NK didn't know. And he had a dealing with Mr. Kim for having the advantageous position in the international sports community. In result, all of us were fairly taken in.", "As you know, NK was glad to accept in the early 1980s. From that time, NK had every scenarios which was the result of estimate. We forgot regular mode of NK for a short time. NK already estimated the interests from holding all the aces of Taekwon-do" said Mr. Hwang.

Not only a hundreds of thousand USD which Mr. Kim gave Mr. Chang, but over a million USD of ITF, he, in spite of General Secretary, said he didn't know their locations. He insists that money came to NK or Mr. Chang Ung's purse.

The illegal president Chang Ung worked alone with the title of the ITF in the international sports community. He hasn't followed any advise from the consultative committee. Since he was elected at the illegal congress, he has done everything illegally. In particular, he banned the Merger committee which was set by the late Gen. Choi and discussed the merger with Mr. Kim in privacy.

In addition, Mr. Chang Ung made the entire Vienna Headquarters building be occupied by only North Korean and made the ITF look like a completely North Korean group. Mr. Hwang attempted to inform the fact to their members. Finally, the illegal president Chang Ung expelled him from his group on 21th FEB. Of course, they had the vote whether Mr. Chang Ung step down or not. But the vote was in Chang Ung's side because almost person of the committee was North Korean or concerned person.

Mr. Hwang also said about the last words of Gen. Choi. He said "Mr. Jong Jae Hun (Vice chairman of the Chosun Taekwon-do committee, General Secretary of the IMGC **he hear the last word by his own ear because Gen. Choi could not speak aloud. After hearing Gen. Choi's whispering, he spoke aloud again.**) said the successor of Gen. Choi is Mr. Chang Ung. **At then, I should believe it. But now, I confirm NK were cheating me. Of course I and Mr. Rhee Ki Ha, the Senior Vice president, planed and held the special congress, it was the tactics to make Mr. Chang the president. But I didn't think everything had been planed by North Korean.**"

Mr. Rhee Ki Ha will go with Mr. Hwang. Their actions will bring big crisis to Chang Ung's. Above all, his load, Mr. Kim Un Yong has been arrested by South Korean police, resigned from WTF and an Kukkiwon and was submitted to a disciplinary measure by IOC.

Therefore North Korea may be isolated from the international community again.
